PLEASE NOTE - chassis repos would apply with all chassis rental. Charges vary by terminal - please check with the terminal to verify the rate that would apply. Chassis rental would also require flip/lift charges at the rail/depots/ports. These are charges assessed by the rail/depots/ports, not TRANSInternational. You can either contact the rail/depots/ports directly to handle these charges or the charges can be paid in advance on your behalf by TRANS, however it would be an additional \$25 administrative fee added onto each flip/lift charge. (Fees are normally around \$50.00 per flip/lift and there would be two flips/lifts required with chassis rental)
